"This contract contains provision for STALLION/MARE INCAPABLE OF BREEDING. Should the Stallion die, be sold or become unfit for breeding purposes, all advance booking fees, (prior to the mare being bred), will be refunded to Mare Owner, thereby canceling this contract.

Should the mare die, or become unfit to breed, the Mare Owner has the option of breeding another approved mare."

õThis contract contains a <u>LIVE FOAL GUARANTEE</u>. A live foal is described as a newly born foal which stands and nurses without assistance. If a foal is born dead there are RETURN BREEDING PRIVILEGES, if the Stallion Owner is notified within 24 hours of the birth and receives a Veterinarian's statement confirming the death. In the event the mare is disposed of prior to birth of foal, the Live Foal Guarantee will only be valid if a replacement mare is approved by the Stallion owner in advance of a return breeding. If the Stallion should die or become unfit for breeding, the Mare Owner has the option of breeding said mare to another Stallion, as offered, or the Stallion Owner will refund ½ (50%) of the Breeding Service Fee, as paid. õ

"This contract contains <u>RETURN BREEDING PRIVILEGES</u>. Should the mare fail to conceive, abort, miscarry or produce a stillborn foal, the Mare Owner has the privilege to return said mare for breeding services through July 2015 or in the year 2016 breeding season.

No additional breeding service fees will be due, other than the daily mare care expense.ö

" A <u>BREEDERS CERTIFICATE</u> for the relevant Breed Registry Association, will be issued to the Mare Owner after the mare has produced a live foal from this Stallion, and ALL fees as billed by the Kruger Ranch, L.L.C. and/or the attending Veterinarian, are paid in full."

"Stallion Manager may have mare checked by licensed Veterinarian for breeding condition, the cost of which mare owner shall pay. Stallion Owner, Managers and Veterinarians, shall assume no liability for mare that will not breed, cannot conceive, or for accident, sickness or death of mare &/or her foal; but will exercise reasonable effort to settle mare and use good judgment in care and supervision of mare. Mare Owner shall not be responsible for injury or accident to Stallion or Management personnel."

"All fees for artificial insemination &/or Veterinarian work will be billed to the mare owner directly from the servicing Veterinarian, and must be paid when billed. If there is an outstanding balance due on the mare owner@ account, the balance due must be paid as billed or account will be assessed billing penalties. A breeders certificate will not be issued until ALL such fees are paid in full.

Any credit terms must be made in advance and such an agreement attached to this contract,

Mare Owner hereby grants a possessory lien [Idaho Code 45-805 (b)], to the Kruger Ranch, L.L.C., for all unpaid fees."
